FEES

ENTRY FEES ARE NON-REFUNDABLE. **MEMBERS: \$25 PER ENTRY**, LIMIT OF THREE ENTRIES PER MEMBER. **NON-MEMBERS: \$40 PER ENTRY**, LIMIT THREE ENTRIES PER PERSON. NON-MEMBERS MAY JOIN AAIE BY PAYING \$25 DUES, AND THEN ENTER AT THE MEMBER RATE.

PICK-UP

ARRANGE FOR YOUR WORK TO BE PICKED UP **4 P.M. TO 5 P.M., SUNDAY, SEPTEMBER 11, 2016**. PAINTINGS WILL NO BE RELEASED BEFORE 4 P.M. SUNDAY. ARTWORK NOT PICKED UP BY 5 P.M. WILL BECOME THE PROPERTY OF AAIE. ARTWORK WILL NOT BE RELEASED WITHOUT A RECEIPT.

GENERAL RULES AND INFORMATION

THIS IS A JURIED ART SHOW. AS IS CUSTOMARY IN JURIED SHOWS, ENTERING THE SHOW DOES NOT GUARANTEE THE WORK WILL BE SELECTED FOR HANGING. ARTWORK WILL BE SELECTED OR DECLINED AT THE DISCRETION OF THE JURY OF SELECTION. NO REFUNDS OR EXPLANATIONS WILL BE GIVEN FOR DECLINED WORK. THERE WILL BE AN ATTEMPT TO CONTACT ARTISTS WHOSE WORK IS DECLINED BEFORE THE OPENING OF THE SHOW. ART THAT HAS BEEN DECLINED MUST BE PICKED UP PROMPTLY DURING SHOW HOURS.

ELIGIBILITY: ARTWORK MUST BE NO MORE THAN 3 YEARS OLD, AND MUST BE THE ORIGINAL CREATION OF THE ARTIST. NO GICLEES OR REPRODUCTIONS ARE ALLOWED. ART MAY NOT HAVE BEEN HUNG IN ANY PREVIOUS AAIE JURIED ART SHOW. TEACHER ASSISTED CLASS WORK, CRAFTS, COPIES OF ARTWORK, OR COPIES FROM COPYRIGHTED PHOTOGRAPHS WILL NOT BE ACCEPTED FOR JUDGING. **DIGITAL ART, ORIGINAL PIECES CREATED ENTIRELY ON THE COMPUTER, WILL BE ACCEPTED ONLY IN THE MISCELLANEOUS CATEGORY.** ARTWORK MUST BE OF SUCH A NATURE AS NOT TO OFFEND THE SENSIBILITIES OF THE PUBLIC.

PREPARATION: PAINTINGS MUST BE SUITABLY FRAMED, READY TO HANG, WITH TAUT WIRE AND HARDWARE TO SUPPORT THE WEIGHT OF THE ART. NO SAW TOOTH HANGERS. **(SEE HANGING INSTRUCTIONS ON THE AAIE WEBSITE.)** ARTWORK MUST BE PRICED OR LABELED NFS (NOT FOR SALE). MATTED WORKS OR WORKS ON PAPER REQUIRE GLASS OR PLEXIGLASS PROTECTION. FOR SAFETY REASONS, ARTWORK MEASURING MORE THAN 20 INCHES MUST HAVE SHATTERPROOF MATERIAL SUCH AS PLEXIGLASS. PAINTINGS MUST BE THOROUGHLY DRY AT TAKE-IN. ALL SCULPTURE AND ARTWORK, INCLUDING FRAME, MUST NOT EXCEED 48 INCHES IN ANY DIRECTION. SCULPTURE MUST BE EASILY CARRIED BY ONE PERSON, AND NO PEDESTALS ARE ALLOWED.

LIABILITY: NEITHER ASSOCIATED ARTISTS, NOR ANY OF ITS AGENTS, WILL BE HELD RESPONSIBLE FOR THEFT, FIRE, INJURY, OR DAMAGE OF ANY SORT TO WORK SUBMITTED FOR THE SHOW. ANY OF THE ABOVE RULES MAY BE CHANGED AT THE DISCRETION OF THE SHOW COMMITTEE. SUBMITTING AN ENTRY TO THIS SHOW SHALL IMPLY AN AGREEMENT ON THE PART OF THE ENTRANT TO THE ABOVE.
